

**West Virginia State Parks
Cabins, Lodge Rooms and Cass Company Houses
Pet Friendly Lodging Agreement**

To make your stay more enjoyable, West Virginia State Parks and Forests designates specific cabins and select lodge rooms, and Cass Company Houses at many state operated areas for guests who travel with their pets. Dogs and cats are the only pets permitted in West Virginia State Parks and Forests. Pets are welcomed in pet designated accommodations.

- 🐾 LODGES:** A **\$25.00** charge per pet for the first night of the stay and **\$10.00** per pet for each additional night, maximum **\$75.00** per visit for all pet friendly lodge rooms.
- 🐾 CABINS AND COMPANY HOUSES:** A **\$50.00** charge per pet for the first night of the stay and **\$5** per pet for each additional night per visit for all pet friendly cabins or Cass Company Houses.
- 🐾 DAMAGES:** A credit card is required at check-in. You will be responsible for any damages, and your credit card may be charged a minimum of \$200 for any repairs or deep cleaning necessary. Additionally, any subsequent loss of future room revenue may also be your responsibility if room reservations must be cancelled due to the damage.
- 🐾 LODGE ROOMS:** Pets shall be permitted in the pet friendly designated lodge rooms only.
- 🐾 NUMBER AND SIZE OF PET(S):** A maximum of two (2) pets are permitted, designated accommodation. A weight limit of 15 pounds per pet in lodge rooms is enforced.
- 🐾 CRATE PETS:** Pets should always be accompanied in lodge rooms. If you leave your pet in your lodge room please crate your pet and kindly let the front desk know in case we need to contact you.
- 🐾 HOUSEKEEPING:** To maintain proper health and safety standards, lodge rooms are serviced daily; however, for employee safety, service to your room only occurs when the room is vacant or when the pet is securely crated. We reserve the right, with providing you advance notice, to inspect and/or clean your lodge room during your stay.
- 🐾 PUBLIC SAFETY:** Pets shall be restrained at all times in public areas on a sturdy leash maximum ten (10) feet in length and in accordance with the general rules. Public areas include lobbies and guest room corridors that are used to access the assigned pet friendly room.
- 🐾 SANITATION:** Guests must clean up after their pet(s) including the lawn around outside the lodge room. If designated walking area in or near the lodge area are provided, it must be used.
- 🐾 PET FOOD:** Secure pet food inside the designated accommodations. Food left outdoors attracts nuisance wildlife.
- 🐾 OUTDOORS:** Please keep your pet from being chained or tied on balconies, porches or in lawns.
- 🐾 PET HEALTH:** Pets must be current on vaccinations and in good health. A veterinarian certification of rabies vaccination is required.

I hereby agree to be bound by all of the above listed pet policies. I also agree to indemnify the State of West Virginia and hold the State and its employees harmless for any damage my pet(s) cause to third parties or the property of third parties. I also understand that the State has no responsibility for the safety or care of my pet(s) and release the State from all liability related to their care and safety. The management reserves the right to terminate this stay without refund, should my pet(s) become considered a nuisance. Violation of this policy or damages caused by your pet may prevent me from participating in this Pet friendly Lodging Program at all West Virginia State Parks and Forests in the future.
